BPO and JoAnn Falletta receive GRAMMY nomination for 'Best Orchestral Performance'

Their 2023 album of works by Alexander Scriabin is one of five recordings nominated worldwide

The Buffalo Philharmonic Orchestra and Music Director JoAnn Falletta are thrilled to announce their nomination for the <u>2024 GRAMMY Awards</u> in the category of Best Orchestral Performance. The nomination recognizes the high caliber of the orchestra and Maestro Falletta's recorded performance of two works by composer Alexander Scriabin – <u>The Poem of Ecstasy and Symphony No. 2</u> – released in February 2023 on the renowned classical music label, Naxos. This category awards both conductor and orchestra, with other nominees including Gustavo Dudamel and the Los Angeles Philharmonic, Karina Canellakis and the Netherlands Radio Philharmonic Orchestra, Yannick Nézet-Séguin and the Philadelphia Orchestra, and Esa-Pekka Salonen and the San Francisco Symphony.

Throughout Falletta's 25 years as BPO Music Director and an equally long partnership with Naxos, she and the orchestra have shared a dedication to presenting unique, lesser-known compositions with audiences across the globe through their recordings. Their nominated album upholds this commitment with the music of Alexander Scriabin (1872-1915), a composer known for his unconventional approach to music with works that stir both musical controversy and admiration.

Falletta describes Scriabin as "a poet, a visionary, a mystic, a painter of dreams, whose extravagant music is perfectly suited to the deep-throated romantic sound of the Buffalo Philharmonic." *The Poem of Ecstasy* (composed 1905-1908) stands as Scriabin's single-movement Symphony No. 4, rich in its creative expression. His Symphony No. 2 (1901), with lush orchestration and emotional landscapes, showcases his artistic vision throughout a nontraditional five movements.

The album has received <u>rave reviews</u> from many of classical music's most well-known critics and publications, including:

Having received multiple GRAMMY nominations and awards in the past, this nomination upholds Falletta and the BPO's world-class reputation. Falletta comments, "I am very proud of the achievement of our fantastic BPO musicians in winning this GRAMMY nomination. Their technical excellence, musical artistry, and exuberant personality are on full display in this dramatic repertoire. We wish to express our thanks to our superb engineer and producer, Bernd Gottinger."

The 2024 GRAMMY Awards will be broadcast on CBS on Sunday, February 4, 2024 at 8 p.m. ET. The GRAMMY Premiere Ceremony, where the majority of the categories are awarded including Best Orchestral Performance, will be streamed live earlier in the



day on **GRAMMY.com**.

About JoAnn Falletta and the BPO's recording history:

The Buffalo Philharmonic Orchestra takes pride in its rich history of musical exploration and innovation. Its partnership with Naxos stands as a testament to a shared dedication to bringing lesser-known works to the forefront. Guided by the wisdom and encouragement of Klaus Heymann, the orchestra has delved deep into the symphonies of artists such as Vítězslav Novák, Joseph Suk, Marcel Tyberg, Reinhold Glière, Zoltán Kodály, and many other talented composers.

In their commitment to diversifying offerings and reaching a broader audience, the BPO established the Beau Fleuve label in 1999. Drawing its name from the moniker given to the Western NY region by early French missionaries, it celebrates the beauty and majesty of Niagara and its cascading falls. This homegrown label has enabled the BPO to curate a varied selection of musical narratives, from pieces commissioned by the orchestra, solo endeavors by principal players, recollections of tours, to the melodies that have resonated deeply with audiences. The Beau Fleuve label has become a platform to showcase the best performances from JoAnn Falletta's International Guitar Concerto Competition, to embrace classical compositions, to honor living American composers, and to feature soloists who have shared a special bond with the BPO.
